**Project abstract:**

In view of the Federal Government's programs to encourage reading, we will take as a basis the PNLD Literary 2018, which took the place of the PNBE (National School Library Program). One of the proposals, already in the Presentation of the PNLD, directed to the teacher, is that "we can increasingly qualify the practices of literary reading and training of young readers carried out in our schools and outside them. We can see the concern with reading practices and, as much as there are challenges in the classroom, teachers can help by sharing discursive experiences about the works, confirming the pedagogical potential of reading. We want to understand how the works can subsidize the development of reading gestures involving the Preschool Fields of Experience (BNCC, 2018). From the preschool collection (category 3 - PNLD), we surveyed the Adhesion Reports of the books chosen in Guarulhos, a region surrounding Unifesp, and we will analyze the works with more than 20% of choice. We checked the reports of 128 municipal schools and 100 of these institutions have pre-school education. We will anchor this research in the works on Reading developed by Freire (1988; 1989), Lajolo (1993; 2004; 2018), Chartier (1999), Carneiro (2002), Yunes (2002), Wolf (2019), and in the official documents that concern the reading journey in Basic Education, focusing on Early Childhood Education. With the reading and analysis of the works, we argue that literary books can subsidize the development of reading gestures in the classroom dialoguing with BNCC axes, highlighting the importance of the works and making the proposals available as Open Educational Resources (OER), as a contribution of our research to the school community.
